

Schlieren, 15 December 2020

ARYZTA held its 2020 AGM this morning in Schlieren. Based on Article 27 of the Ordinance 3 issued by the Swiss Federal Council on measures to combat the coronavirus (COVID-19) of 19 June 2020, the AGM was held without the presence of shareholders.

Shareholders representing in excess of 74% of shares eligible to vote approved all Board proposals with the exception of the proposal from Lodbrok to re-elect Alejandro Legarda Zaragüeta as member of the Board of Directors. The Board had proposed to reject this proposal.
